AMERICAN DANCE TRAINING CAMP 2009 REGISTRATION PROCESS & POLICIES

To Apply:

- Be sure that you understand ADTC's registration policies before applying.
- Fill out application as directed. Call 866-383-ADTC if you have questions. Or, quick and easy online registration is available at www.AmericanDanceTrainingCamp.com/register.html.
- Don't forget to sign the parent/camper agreements. Unsigned applications will not be processed.
- Fill out your credit card information. (Visa or MC only)
 - Prior to April 15: **Minimum \$300 deposit per-camper, per-session is required.** Full payment is recommended to receive an additional 5% off. Early Bird or Alumni rates apply.
 - After April 15: Full payment is required with your application. Regular rates apply.
- FAX or Email your completed application: FAX: 866-383-2382. Email ADTC@ASDance.com. Please DO NOT MAIL your application - it may be unnecessarily delayed via mail.

Application Policies:

GENERAL INFO: American Dance Training Camp is open to girls ages 8 – 17. No prior dance experience is necessary to attend.

FAMILIES: All rates are quoted on a per-session/per-family basis. If your family is sending two girls for one session each, you pay the two-session rate.

GROUPS: Group applications MUST be faxed or emailed together in the same communication to qualify for the discount. Groups of four or more girls applying together from the same dance studio are considered "family" for application purposes. If four or more girls from the same studio attend one session each, each pays the three+ session rate. Group members are NOT REQUIRED to attend the same session/s. Groups of seven or more are entitled to register one teacher at no additional charge, but ONLY IF all group members and the teacher attend the same week/s of camp.

DAY CAMPERS: Day campers pay the same rate each session – there is no discount per session for attending multiple weeks as a day camper.

WHAT'S INCLUDED: The weekly session price includes room & board from Sunday afternoon through Saturday morning, three meals per day (with the exception of lunch & dinner on Saturday and breakfast & lunch on Sunday for multi-session campers), all dance classes Monday through Friday, and most daily activities (arts & crafts, team events, night activities, etc.) Saturday night is included in the price for campers staying multiple weeks. For information about Optional Activities, please see below.

SPACE AVAILABILITY: ADTC cannot guarantee that space still will be available in any given camp session when your application is received. Registration is first-come, first-served. Upon receipt of your application and your deposit or full payment (see "Payment Requirements" below), we will email you to confirm your session dates based on current availability.

SESSION CONFIRMATION: If you do not hear from us within two weeks of faxing or emailing your application, please call 866-383-ADTC. To allow for processing time, please wait two weeks before calling. Mailed applications may take up to 4 weeks to be received and processed.

DISCLAIMER: ADTC reserves the right to refuse an application and/or dismiss, without refund, any camper at any time for reasons which, in its sole discretion, are in the best interest of the camp.

Payment Requirements:

A minimum \$300 per-session/per-camper deposit MUST accompany each application sent prior to April 15. For applications sent after April 15, your full tuition payment (charged at the regular rates) is due with your application.

All outstanding tuition balances are due in full on or before April 15, 2009. All final payments must be received by this date to qualify for early-bird or alumni tuition. Any tuition balances still outstanding after April 15 will no longer qualify for any discounted rate and will be recalculated at the applicable regular rates. Additionally, campers who have sent deposits and been given confirmed session dates prior to April 15 but who do not pay in full by this date may lose their originally requested sessions, while still being held to the terms and conditions of ADTC's cancellation policy (below). Campers with outstanding balances after April 15 must pay their entire balance due (including any associated late charges, see below) before ADTC can attempt to re-accommodate them.

Account balances that remain past-due after May 15, 2009 will incur a \$25 late charge. Balances still outstanding after June 15, 2009 will incur an additional \$25 late charge. If possible, ADTC strongly recommends that you send payment in full with your application on or before April 15 to avoid any potential confusion and extra tuition charges later-on.

Registration Packets:

Registration packets will be emailed to all paid-in-full, confirmed campers starting in mid-April. If you are applying after April 15, your registration packet will be emailed within two weeks after your registration has been accepted. If you would prefer to have your registration packet mailed USPS, you must contact the ADTC office: ADTC@ASDance.com.

Optional Activities Fees & Requirements:

Optional activities and field trips requiring additional fees will be described in the registration packet sent to confirmed campers. Permission slips for those activities will also be included in the packet. Fees and permission slips for the optional activities and field trips requiring them must be paid by June 1.

Most optional activities are only offered once per week, though some are offered two or more times per week (please see our website for details). If your camper will participate in any of our additional-fee activities, the cost will be withdrawn from her "Activities Account" (unless you purchased the "Unlimited Activities Pass" during registration). All campers register for activities during the Sunday afternoon team meeting - they can only register for activities if you have included enough money in their Activities Account AND signed the necessary waivers (which will be emailed to you with the registration packet and available for download from our website in April).

Due to weather, availability &/or scheduling conflicts, we may be unable to offer all advertised activities during your child's session. Please note that if your camper does not report at her assigned time to participate in an activity for which she is registered, her participation fee is non-refundable. However, if an activity must be cancelled by ADTC, the activity fee will not be charged to the camper's Activities Account. Unfortunately, no individual activity fee refund or refund of any kind can be made for campers who purchased the "Unlimited Activities Pass."

Medical & Insurance Requirements:

All campers must be covered by their own medical insurance. All campers must have a completed ADTC Health Form which requires a physical examination no earlier than two years prior to attending ADTC. Required health forms and all pertinent information will be emailed to confirmed campers with the registration packet.

Cancellations, Changes & Refunds:

Once your application has been accepted by ADTC, any cancellations or desired changes to your session dates must be requested in writing via email to ADTC@ASDance.com. Session changes will incur a \$25 per session processing fee and are granted at the sole discretion of ADTC, based on availability. If a session change cannot be accommodated, the camper may cancel according to the following policies:

- Prior to April 15: Tuition and activities fees less a \$150 processing charge will be refunded.
- After April 15 and up to thirty days prior to the registered camp session: Tuition and activities fees less the \$300 deposit per session will be refunded.
- No refunds can be made if a cancellation is within thirty days of the camper's session. No exceptions.
- No refunds can be made if a camper withdraws at any time after arriving at camp. No exceptions.
- There is no reduction of fees for late arrival or early departure. No exceptions.

Exclusive Alumni Discount:

To qualify for the ADTC Alumni Tuition Discount, you must be an ADTC alumni and your application MUST be received by December 15, 2008. If this criteria is met, you qualify to cancel your registration and receive a full refund with no penalty at any time prior to April 15, 2009. You also may request to change your requested session-weeks with no penalty at any time prior to April 15, though ADTC cannot guarantee that space will be available in any given camp session when your request is received. If ADTC is unable to accommodate your requested session change/s and you have made your request prior to April 15, you will receive a full refund. The Alumni Tuition Discount terms and conditions are subject to change at any time. ADTC reserves the right to modify, suspend or cancel this offer without notice.
