Please note that all optional activities below require parental consent and some require additional fees and/or additional waivers as indicated. Please check the box for activities in which you give your child permission to participate--campers may only sign up for activities that you check and sign for here.

- Fondy Sports Park (Once per session, weather permitting)** - Activities to be enjoyed include go-karts, mini-golf, hi-ball, paintball, arcade, bumper boats, batting cages and more! **Cost \$40** (extra spending money recommended).
- Swimming (3+ times per session, weather permitting)** - We'll cool off at the campus swimming pool! **CAMPER MUST BE A SELF-SUFFICIENT SWIMMER. No cost.**
- Friendship Bracelet Class (Once per session)** - Craft. **Cost \$5.**
- Lake Trip: Beach & Paddle Boats (Once per session, weather permitting)** - Have fun paddling at nearby Crystal Lake - sandy beaches, swimming and fun outdoor activities. There is a concession stand available. **Cost \$20** (extra spending money recommended).
- "Thoroughly Modern Mille" (Once per session - evening performance)** - Beaver Dam Community Theatre's production of the Tony Award winning musical. **Cost \$20. We all will be attending this theatre event together!**
- Tennis (Twice per session, weather permitting)** - Come out and play at the nearby tennis courts! Don't forget to bring your racket! **No Cost.**
- Dance Scrap-Booking (Once per session)** - Craft. **Cost \$15.**
- World Dance Company (Mon-Thurs evenings, subject to availability/offerings)** - Campers can elect to participate in this unique company and learn a special dance piece to perform in the Friday night show. Nightly rehearsals will be held after dinner. Participation is optional and campers who participate receive a certificate of global awareness. All proceeds go to the "Chandler Sky Foundation" (a Peruvian orphanage) or similar program chosen by the company members. **Cost \$15.**

3. I willingly agree to comply with terms and conditions for participation. If I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately.
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS THE AMERICAN SCHOOL OF DANCE, LLC**, its officers, officials, agents and or/employees, other participants, vendors, advertisers, the United States, the States of Vermont, California, Colorado, Utah, North Carolina, Wisconsin, Illinois, New Mexico, New Jersey, Connecticut, Oregon, and Washington from any and all claims, demands, losses, and liability arising out of or related to any **INJURY, DISABILITY OR DEATH** I may suffer, or loss, or damage to person or property, **WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE**, to the fullest extent permitted by law.
5. **Transportation Release:** Select members of ADTC staff may transport campers in their fully insured and State inspected Vehicles. All staff cleared to transport campers must have a clean driving record. At Program Director's discretion, campers and staff may also choose to take cabs and/or other area transportation.
