## ADTC COVID-19 Prevention & Family Code of Conduct

We do not just exist by ourselves alone - each of our actions impacts the whole. ADTC is committed to providing the safest and most enjoyable in-person dance camp experience possible. To achieve this, we are focused on a multilayered approach to mitigating COVID-19 at all ADTC in-person camps. Our approach may vary by location, resources available, and local guidance.

This Family Code of Conduct outlines our behavioral expectations for ADTC campers, staff and families in order to live, learn, and dance in-person together this summer. By signing below and joining us for camp, you agree to follow the behaviors detailed in this Code of Conduct, and respect any policy changes we may need to implement before check-in. All of us in the ADTC community have a responsibility to balance health & safety needs with our [A.D.T.C. core values](#).

I understand, as a member of the ADTC community during the 2022 summer, that I am an important part of ADTC and that we are stronger as a community when we all do our part to keep our community safe. I will do my part to limit the spread of COVID-19 by adopting behaviors that advance our collective ability to reduce the transmission of COVID-19 and make my own health and safety and that of others a priority. Specifically, I pledge to:

- Follow federal, state, and local health guidance leading up to camp, and make any adjustments as necessary.
- Abide by all COVID-19 protocols that may be implemented by the state, county, host facility and ADTC during camp.
- Monitor camper's health (temperature, symptoms, etc.) prior to check-in. If at any time within 14 days immediately prior to arrival, 1) the camper tests positive or experiences [COVID-19 symptoms](#), or 2) we learn that she has been in "close contact" ([as defined by the CDC](#)) with an individual who has received a COVID-19 diagnosis or has experienced COVID-19 symptoms, she should not come to camp until she [meets the CDC requirements](#) for being in public spaces.
- Avoid environments where federal, state, and local health guidelines are not followed in the 14 days leading up to camp.
- Provide results of a negative PCR or antigen test taken 1 - 3 days before check-in, as required (tbd closer to camp).
- Complete a daily camper health screening w/ temperature & symptom check every day at camp.
- Maintain physical distancing & wear a well-fitting, high quality mask inside buildings, on buses, etc. if/when required.
- Practice good personal hygiene consistent with public health protocols, such as frequent hand washing, appropriately covering coughs and sneezes (with elbow, not hand), use of hand sanitizers, etc.
- Respond cooperatively and respectfully to reminders and provide gentle reminders to those who appear in need of them.
- Follow instructions for quarantine/isolation/pick up if I test positive or experience COVID-19 symptoms at camp, or if I'm considered a close contact of someone who tests positive or experiences symptoms at camp.
- Seek testing for COVID-19, as directed by the camp.
- Be responsible & compassionate through my actions & reactions if there is a case of COVID-19 in the ADTC community.
- Limit contact with others, especially high-risk individuals, for at least two weeks after returning home from camp.

To provide everyone on campus with a reasonable sense of security, we must all agree - and know that everyone else at camp has agreed - to abide by these behavioral guidelines. COVID-19 is a known risk, and refunds will not be granted for camp attendance lost due to COVID infection, exposure, or policy changes. These guidelines are current as of 4/25/22 and may be modified and further specified over time as changes require.

I understand that my failure to adhere to the ADTC COVID-19 Prevention & Family Code of Conduct may put others at considerable risk, and - if nothing else - places peers and ADTC staff in the unwelcome position of policing my behavior. If I am unable to honor my pledge, I understand that I will have forfeited the privilege of remaining at camp, and, in order to promote health and safety, ADTC may take action to prohibit me from participating in any in-person camp activities.
